

The net (item 1) should be placed at the sector boundary with the net poles (item 2) and the ground pegs (item 3) according to the scheme below.





Fix the top perimeter rope and the bottom perimeter rope in the pigtail hooks of the net poles (item 2). Then fasten the bottom perimeter rope with the ground pegs (item 3).



V. Operation and maintenance



After each use the net poles and ground pegs should be cleaned and dried. During the idle periods the product should be stored in a dry roofed place. If the net gets wet, it should be left to dry before storing.

VI. Packing and transport

The set is wrapped with foil and put on a pallet. Gross weight 59,4 kg.
