Specific warranty terms – Athletics crossbars

- 1. Athletics crossbars are designed to be used in athletics training and competitions of high jump and pole vault jump. Due to the detailed technical requirements concerning the construction of the crossbar (see Competition Rules 2014-2015 issued by the International Association of Athletics Federations IAAF located in Monaco: 17, rue Princesse Florestine, BP 359 MC 98007 Monaco Cedex, tel. +3377 93 10 88 88, fax +377 93 15 95 15, www.iaaf.org) and relatively high pressure exerted by a jumper during failed jumping or vaulting, it may happen that the crossbar breaks under the pressure and in that way it protects the jumper against a serious injury. The case is recognized as a normal wear of the product and it is not a ground for complaints.
- 2. If the further tests of the claimed crossbar(s) are required (according to point 2. of the POLANIK European Warranty Certificate/ POLANIK Worldwide Warranty Certificate), the authorized Polanik department shall inform the complainer which parts of the claimed crossbar(s) are to be delivered to minimize the transport costs.
