The product is an electronic device and it requires careful handling!

1. General use

ZPCP14-K comfort set with cascade is the timing system enriched with an additional photocell. It is significantly more accurate than the set with one photocell, because the time of the competitor is recorded when two infrared beams are tripped at the same time. The set measures the times with the resolution up to 1/1000 s. The shot from the staring revolver initiates the timing of the chronometer which can record up to 2000 results. Thanks to the thermal printer of the chronometer the results can be printed out.



3. Assembly of the set

The example of the wiring the set is presented below.



At the start line the starter fires the starting revolver RS-START9, which is connected with the chronometer CHR through the 150 m cable PNB-150. At the finish line the two sports photocells FP are screwed to the cascade holder UFP-2 and mounted on the tripod ST. they are connected to the chronometer CHR. The photocells are pointed to the double reflector LFP-2 mounted on the tripod ST.

4. Maintenance

The set elements are precision instruments, so they require careful handling. When the set is not used it should be stored in a dry roofed place.
