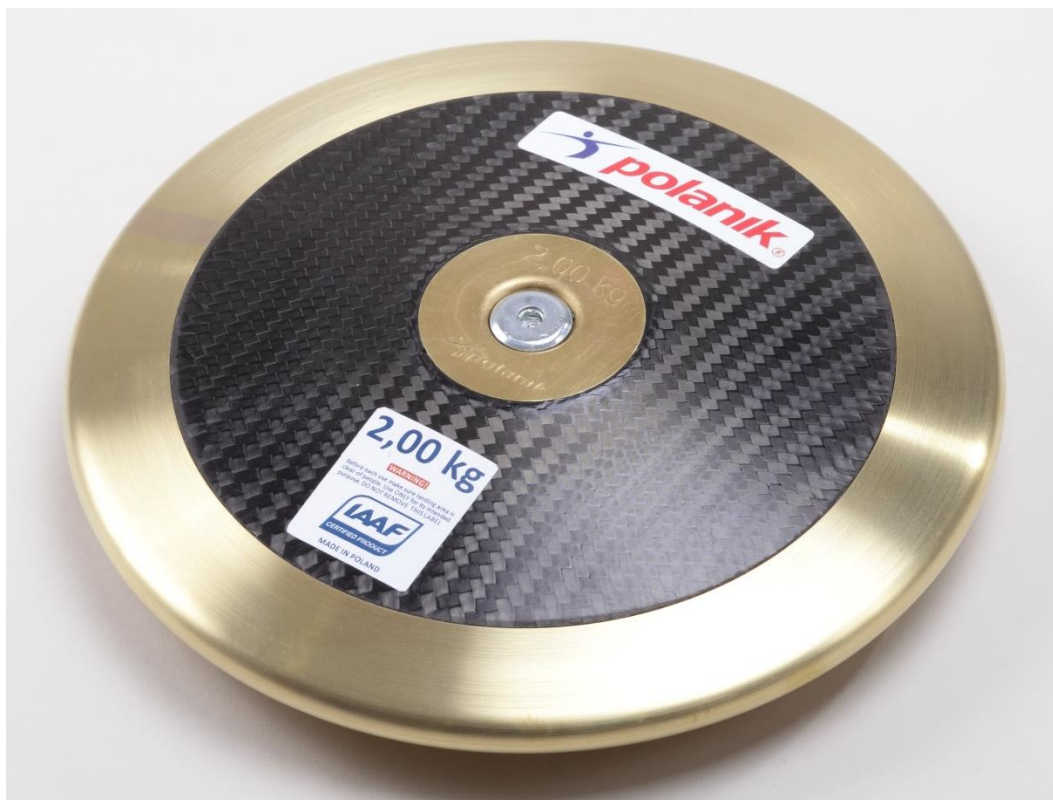

- 2) The discuses are athletics throwing implements designed for the athletics competition event – discus throw. The mechanical damages of the discuses (scratches, dents and so on) caused by landing on the throwing sector or other discuses remaining on the throwing field are recognized as a normal wear of the product and are excluded from the warranty.

I. Use

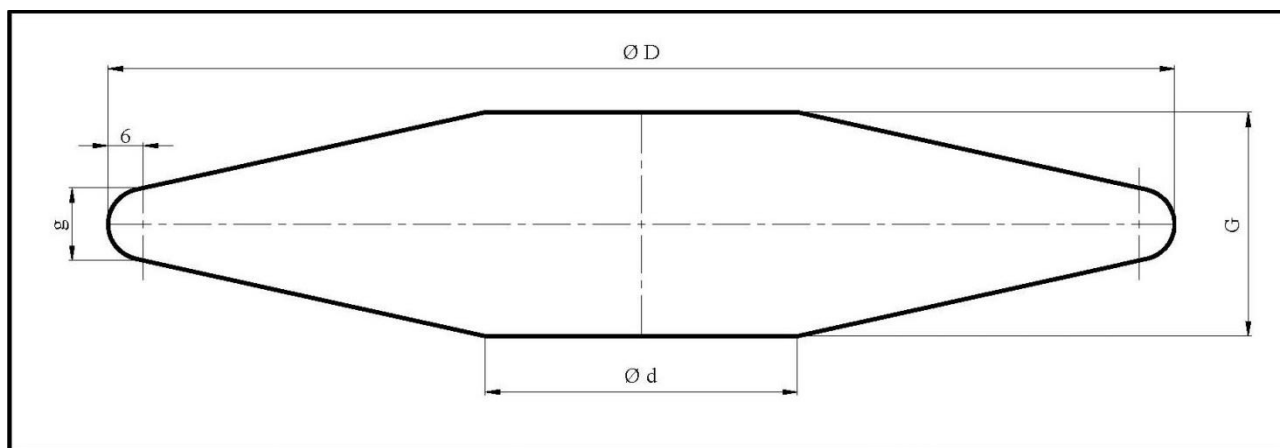

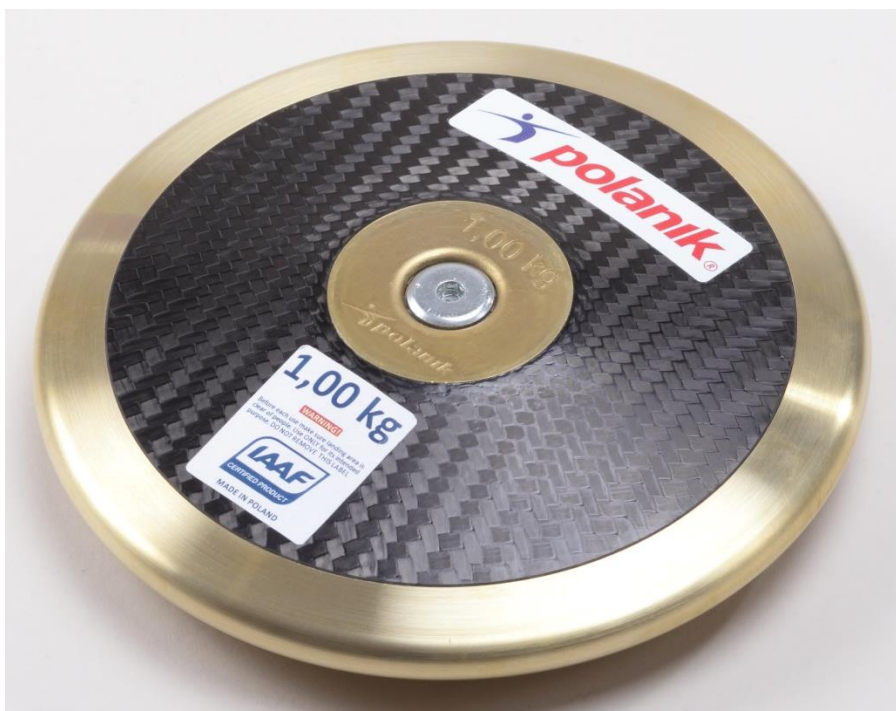

The discuses should be used on grass ground only. The throwing field should be free of hard objects and thrown discuses should be removed regularly during training and competitions.

IV. Packing and transport

The discuses are packed in paper bags and foil bags. Each discus comes with synthetic fabric carrying bags. Then each discus is packed in a 3-layer cardboard box.


